Moot Court No. 2

On 24th January, 2020, police from the Sawantwadi police station while patrolling arrested Vinod on suspicion as he was attempting to run away. When arrested he was found to possess a loaded revolver without license. During interrogation he revealed about his implication in murder of a young girl Neesha, sister of Mrs. Nurani Makhija, wife of famous business tycoon Mr. Bunty Makhija. Vinod confessed to the police that in December 2010, he conspired and participated in the murder of Neesha along with Nurani and one Santosh Kapoor from Dehli.

Police started the investigation and found that in January 2011, Mr. Jhony Makhija, son of Bunty Makhija had lodged a missing report of Miss. Neesha, his girlfriend, in the police station. He told the police that he met Neesha on 15th December, 2010, after her office hours. They spent some time together and then Neesha received a call from Nurani and then he dropped her at Seven Love Chowk at about 8.00 p.m. At that place, he found Nurani along with her driver and one other man was waiting for Neesha in her car. Police then tried to find out the whereabouts of Neesha and in this process they visited the company where Neesha was working. The officer from the Company revealed that on 16th December they received the resignation letter from Neesha. In the mean time Jhony received a message from Neesha that she wished to break-up the relationship with him and didn't want to have any sort of communication with him. Jhony also produced the original passport of Neesha which was in his possession. Police searched the flat where Neesha was residing and contacted Nurani. Nurani at that time was in U.K. for some business work and said that her sister Neesha had taken admission in one of the University in U.S.A. and agreed to visit the police station personally on her return to India. When asked about the passport, Nurani said that as Neesha's passport was lost, she prepared another passport for leaving to U.S.A. Being satisfied with the information police closed the investigation and refused to lodge the missing complaint.

Vinod then accompanied the police to the place, near Songaon, a village approximately 75 k.m from Sawantwadi, where he along with Nurani and Santosh disposed of the body of Neesha. Police on digging the place, shown by Vinod found some bones which were sent for further medical investigation. The police patil of village Songaon informed the police that in January 2011, villagers of Songaon made the complaint of some foul odor in the jungle area adjacent to the village. Police made search and found decomposed burnt body. It couldn't be identified and the remains were sent to government hospital.



In the course of investigation, Police met Nilesh, brother of Neesha who revealed that Neesha was not the sister of Nurani but her daughter. He further informed that he and Neesha were children of Nurani and Mr. Amit Gupta, a businessman from Agra. These two kids were raised by their maternal grandparents and he remembered Nurani visiting them very rarely, only on two occasions. He further said that on completing her school education, Neesha being impressed by the lavish lifestyle of Nurani, shifted to Sawantwadi for living with her. Nilesh said that their mother Nurani, must have killed Neesha for suppressing the truth of her past life being exposed to whole world..

Friends of Neesha informed, Neesha to be very happy and peaceful girl. She was said to be in the relationship of Jhony and was living with him in the flat. Preeti, who was known to be very close friend of Neesha said that Neesha was reluctant to discuss in detail her relationship with Jhony as her relationship with Jhony who actually was her step brother, was not approved by Nurani and Mr. Bunty Makhija. Vinod gave the detail story of murder of Neesha to the police officer. He said approximately in October 2010 he was contacted by Mr. Pawar personal assistant of Nurani who asked for his assistance in committing murder of one woman for the consideration of Rs 10lakh. On his acceptance, he was asked to wait for further instructions. He said, then on 14th December, 2010 he received a call from Pawar who asked Vinod to be at Seven Love Chowk at about 6.00 p.m, on 15th December. He went there and met Nurani and Mr.Santosh. All of them waited there approximately for an hour and then a young girl came who was introduced to him as Neesha. He said then, on that day, he drove Neesha alongwith Nurani and Santosh Kapoor from Seven Love Chowk to the remote and lonely area out of the city. Neesha was sitting on the back seat along with Nurani. Nurani gave Neesha the cold drink consisting of some substance due to which Neesha lost her conscious. Then Noorani tried to strangulate her but as Neesha opposed she asked for help of Santosh. Then Santosh went to help her and both of them silenced Neesha. Then Noorani said that she has searched a nice place for disposing her body but at it was about 11.00 p.m. they decided to return to their place of residence. Accordingly he dropped Nurani and the dead body of Neesha at Nurani's place. Santosh assisted her to take the body of Neesha inside the house. He then went to the hotel and on the next day early in the morning he picked up Nurani and Santosh at Nurani's house. This time they had a big bag containing the body of Neesha. Then as directed by Nurani, he then drove to the Songaon where Nurani and Santosh tried to burn the body of Neesha in the jungle area adjacent to the village. After that, Vinod then drove Nurani and Santosh to Sawantwadi and dropped them to the house of Nurani.

On the basis of investigation conducted, police framed the charges against Nurani and Santosh and then in due course of time the trial commenced. Both accused



pleaded not guilty. Police decided to make Vinod the approver, accordingly the procedure was followed. He then was granted pardon and deposed before the trial court.

Santosh Kapoor appeared before the court. He admitted his relationship with Nurani, he being her ex-husband, but he denied his involvement in crime. He said in December 2010, he visited Sawantwadi for meeting his daughter Ruchi who was taking education in university. He accidentally met Nurani on 15th December, 2010 and has nothing to do with the crime alleged. He refused to recognize Vinod.

The remains of the human body which police found were sent for medical examination along with the remains preserved by the government hospital. The report of the medical examination revealed that the remains recovered by the police and the remains preserved by the hospital were of the same human body. Further the DNA test revealed that the remains recovered by the police were of female issue of Nurani.

In the trial, the investigating officer appeared before the court and in his examination deposed about the investigation made by him and specifically the confession made by Vinod.














The trial court convicted Nurani and Santosh under sec 302 and sec 201 along with sec 34 and punished them with imprisonment for life.

Against the conviction, both Nurani and Santosh appealed to the High Court. While challenging the conviction, Nurani contended that the trial court has committed the grave error on relying upon uncorroborated testimony of Vinod as approver. She further contended that trial court has erred regarding the admissibility of testimony of investigating officer specifically regarding confession of Vinod. Santosh in his appeal said that circumstantial evidence adduced before the trial court was not adequate to justify the conviction.
