NSS SPECIAL CAMP AT AMBI 7 TO 13 JAN 2022





➤ **Village cleanliness drive – 8/01/2022 To 12/01/2022**







LEGAL AID CENTRE EXTENSION ACTIVITY REPORT (A.Y. 2021-2022)


The Legal Aid Society is built on one simple but powerful belief: that no Indian should be denied the right to equal justice. We seek to be a beacon of hope Indians who feel neglected regardless of who they are, where they come from, or how they identify. Being an important stakeholder in the legal field, we owe a duty towards society to shoulder the responsibility of providing legal aid to the masses at large. The institutional support provided through Legal Aid Centre of the College will help the society to have access to justice through expertise without any expenses. The students on the other hand will benefit from the practical exposure and knowledge which they will gain and explore being a part of this Centre and while working on various projects and activities undertaken by the Centre. For the academic year 2019-20 total 166 students registered for the legal aid center.

The Centre conducted the following activities throughout the academic year 2021-22

❖ Training Session of volunteers for National Lok Adalat

Legal Aid Centre, SCLC in collaboration with District Legal Services Authority, Pune conducted a training session for volunteers of all the law college participants in Pune on 24th September, 2021 for National Lok Adalat to be held on 25th September, 2021 in the District Court, Pune.

Principal Dr. Kranti Deshmukh addressed the gathering and showed her gratitude for an opportunity to assist in the conduct of Lok Adalat. Hon'ble Pratap Sawant, Secretary DLSA, Pune District Court, Pune guided student volunteers in all different perspective like the agenda of the




day of National Lok Adalat day to be held. He also explained different kind of matters will be held accordingly in which building, floor and courts rooms. He also provided circular of entire 58 panels sitting on bench for Lok Adalat on that day which was helpful for volunteers to guide litigants in the right direction. 87 Student volunteers from 7 different law colleges participated in this training session.



Lok Adalat's can take cognizance of matters involving not only those persons who are entitled to avail free legal services.

The Cases taken up during the National Lok Adalat were-

- a. Plea Bargaining
- b. Compoundable Traffic Challans
- c. Labour Disputes and Service Matters
- d. Electricity and Water Disputes
- e. No Mask Challans
- f. Matter related to S-138 of Negotiable Instrument Act

Objective-

The purpose of participation is to make aware the students about the working of a National Lok Adalat and to understand the preparation required for the conduct of Lok Adalat. Student volunteers, who assist the Lok Adalat, must understand first the nature of functioning of Lok Adalat and how it resolves various disputes like disputes related to Motor Vehicles, Bank Loan cases, Accidental claims, Insurance Claims etc.


Outcome: Student volunteers learnt about the functioning of Lok Adalat and its actual jurisdiction. Students also learnt that, the Lok Adalat is presided over by a sitting or retired judicial officer as



the chairman, with two other members, usually a lawyer and a social worker. In Lok Adalat's it is easier to settle money claims since in most such cases the quantum alone may be in the dispute.






❖ **Legal Awareness on the topic of services provided by Maharashtra SLSA.**


Student volunteers of Legal Aid Centre, SCLC participated in this activity with large number on 4.10.2021.


to eradicate to achieve our objective that is justice for all” Further he also appreciated the Legal Aid Centre for taking imitative and organizing this programme.


There were more than 100 participants including *Anganwadi* workers who attended the programme.

At the end of the program, Dr. SudhirTarote, In-charge, Legal Aid Centre proposed a vote of thanks.






❖ Legal Aid Awareness Program at *Ashraya*- Initiative for Children



After the competition, all three judges gave their feedback and guided the participant teams about how to perform an effective street play.







❖ **Outstation Legal Aid Camp (30/04/2022), At Village Lavale, taluka Mulshi, District Pune.**


A legal aid camp is a clinic run by law students and lawyers in order to provide instant and easily accessible relief in matters and disputes relating to legalities to the people belonging to indigent and backward classes. By keeping it in mind this year the Centre after the long pause caused by the pandemic, Outstation legal aid camp organized at at Village Lavale, taluka Mulshi, District Pune. The goal was to visit a locality set out of urban limits and spread awareness about certain issues and ensure legal safeguards for the same. The day started with a cheer among the students of the Master's programme of Shankarrao Chavan Law School. We reached the Village – Lavale which is situated in the Mulshi Taluka of Pune District by boarding busses booked by the college organizers. The village is small and quaint. Our teachers and volunteers who had thoughtfully organized this event, then set up a station for breakfast in the campus of these temples. The Students then wandered into the streets of the village to call upon people to come to our legal aid camp. People have gathered by that time. The dignitaries of the event also arrived. In presence were members of the village gram panchayat and some other local authorities. Along with them our program was graced by the presence of Hon'ble Chandrashila Patil Madam who is a judge in the Pune court. Many groups of students, belonging to the bachelors as well as the master's course had prepared posters for educating the people of Lavale. The posters mainly focused on digitalization and use of applications for money transfers, social media, matrimonial websites etc. The display put up by the groups was very knowledgeable and proved to be of great help indeed. They not only made the audience aware of scams and frauds committed through internet but also gave guidelines on how to avoid them. After the posters were read and shown, students belonging to the bachelor's program did excellent street plays and kirtans to convey legal awareness through a more colloquial, entertaining and understandable manner. Furthermore, students also displayed their talent by singing abhangs and capturing the audience's attention by their exceptional skill sets.

After the performances concluded, the guests of honour expressed their thoughts about the legal clinic and the performances and posters displayed by the students. Hon'ble Chandrashila Patil Madam also expressed how and why she related with the villagers and what steps she has taken for creating this legal awareness in her hometown. The village sarpanch also shared his thoughts



and concerns about the legal scenario in the village. He said the village would be pleased if such camps are held frequently and are successful in providing the much-required legal aid to its citizens. He told about the potential of the village and how it is rich in terms of culture, land and resources. Upon hearing his concerns, it really struck a chord with us all and therefore, we and the teachers present on behalf of the college, promised to provide free legal assistance to the village whenever and however necessary. ❖ Participation to conduct of Lok Adalt


District Legal Services Authoirty, Pune had organized National Lok Adalat on 7th May, 2022. Volunteers of Legal Aid Centre, SCLC actively participated in the National Lok Adalat. Lok Adalat's can take cognizance of matters involving not only those persons who are entitled to avail free legal services.

The Cases taken up during the Lok Adalat were-

- Plea Bargaining
- Compoundable Traffic Challan
- Electricity and Water Disputes
- No Mask Challans
- S-138 of Negotiable Instrument Act

The purpose of participation is to make aware the students about the working of a National Lok Adalat and to understand the preparation required for the conduct of Lok Adalat. Student volunteers, who assist the Lok Adalat, must understand first the nature of functioning of Lok Adalat and how it resolves various disputes like disputes related to Motor Vehicles, Bank Loan cases, Accidental claims, Insurance Claims etc.

Student volunteers of LLB I learnt about the functioning of Lok Adalat and its actual jurisdiction. Students also learnt that, the Lok Adalat is presided over by a sitting or retired judicial officer as the chairman, with two other members, usually a lawyer and a social worker. In Lok Adalat's it is easier to settle money claims since in most such cases the quantum alone may be in the dispute.


❖ National Seminar in Collaboration with NLSA,MLSA &DLSA





